Help **Kill** Bill 1442!!

Introduced by Representatives Dan Ruby, Edmund Gruchalla

A BILL for an Act to amend and reenact section 39-21-45.1 of the North Dakota Century Code, relating to modification of motor vehicles.

SECTION 1. AMENDMENT. Section 39-21-45.1 of the North Dakota Century Code is amended and reenacted as follows:

39-21-45.1. Modification of motor vehicle.

1. Except as otherwise provided in this section, a person may not operate upon a public highway a motor vehicle of a type required to be registered under the laws of this state with a weight of ~~seven thousand pounds~~ 16,000 pounds or less with alterations or changes from the manufacturer's original design of the suspension, steering, or braking system of the motor vehicle. ~~The weight must be computed on the basis of the unmodified and unloaded weight of the motor vehicle and without regard to any ballast that may be placed in the vehicle.~~

2. An inspection certificate from the department or highway patrol is required after the completion of all modifications before the motor vehicle with vehicle modifications from the manufacturer's original design of the suspension, steering, or braking systems may be registered.

3. As to bumpers, motor vehicle height, tires, and ~~permitted modifications~~ fenders, the following requirements also apply:

a. The motor vehicle must be equipped with front and rear bumpers.

b. The maximum body height permitted for the motor vehicle is forty-two inches. Measurement of body height is made from a level ground surface to the floor of the cargo area. Air or hydraulic suspension systems used to change body height may not be actuated while the vehicle is in motion. The vehicle body must maintain a generally level stance and body and bumper heights referred to in this subsection must be maintained while the vehicle is in motion.

c. The maximum bumper height permitted is 27 inches. Measurement of bumper height is made from a level ground surface to the highest point on the bottom of the bumper.

d. The vehicle may be modified in accordance with the following:

(1) Any modifying equipment must meet specialty equipment marketing association standards or federal motor vehicle safety standards.

(2) If tires placed on a motor vehicle have a diameter greater than that of the tires on the motor vehicle as manufactured, those tires must comply with ~~department of transportation requirements~~ federal motor vehicle safety standards.

(3) The maximum outside diameter permitted for tires is forty-four inches

(4) A horizontal drop bumper may be used to comply with the bumper height requirement of subsection 3. The horizontal bumper must:

(1) Be at least three inches in vertical width;

(2) Extend the entire horizontal body width; and

(3) Be horizontal, load bearing, and attached to the vehicle frame to effectively transfer impact when engaged.

(5) The maximum lift permitted in the suspension system is four inches

e. A part of a motor vehicle must not extend below the lowest part of a wheel rim except tires and electric grounding devices designed for that purpose.

f. All wheels and tires must be equipped with fenders designed to cover the entire tread width. Tread width is the portion of the tire that generally makes contact with the road surface. Fenders must cover the entire tread circumference from at least fifteen degrees in front, to at least seventy - five degrees to the rear, measured from the vertical centerline at each wheel.

g. A person charged with violating this section has the burden of proceeding to show that the modifications are permitted under this section.

h. Vehicles owned by law enforcement agencies, the military, firefighting agencies, and ambulances may be modified without regard to this section.

4. The director may adopt rules to implement this section.

As of February 25th, the bill passed (there were 59 YEAS to 34 NAYS). The bill now goes to the Senate for hearing, potential amendment, floor vote (pass or defeat), and Governor action.

The bill now does two things: 1) changes application of NDCC 39-21-45.1 from “weight of 7,000 lbs.” to “16,000 registered gross weight” or 8,000 actual gross weight; and 2) calls for an interim legislative study of “regulations of drivers and of motor vehicles in NDCC...”

The Street Rod exemption of NDCC 39-21-52 is not effected by HB 1442 but only applies to pre-1949 vehicles so any vehicle under 8,000 lbs. would be subject to NDCC 39-21-45.1 (bumpers, tires, lift, etc.).

Now , here’s how you can help stop the bill from passing:

There are two ways to prevent passage of a bill.

- One is by directly lobbying either the representatives or their constituents, presenting opposing views and possible negative ramifications of the plan or policy.

- The second is by securing the aid of the other branches of government : the executive and/or the judiciary.

Depending on the power of the Governor in the state, he could influence the bill or even veto it once it is passed. The judicial branch may have reason to influence the bill if it appears to contravene existing precedent or the state constitution. Often it will require that a bill be passed before its constitutionality is determined, but judges sometimes will express opinions that sway the eventual form of legislation.
